#### **Reports from the Executive**

#### Joshua Synenko, President:

Approval of the 2020 Minutes. Welcome and thanks to Program Chair Doris Hambuch for another excellent year and virtual program. 4 points:

# **Doris Hambuch, VP and Program Chair:**

Doris emphasized the support of the Working Group organizers, the Executive, and participants in putting together yet another virtual program. There were 38 abstracts submitted for presentation, and three were rejected. This year's book launch showcased nine books. The conference opened with a showcase of the documentary film work of Mark Terry, in particular, his trilogy of films examining the impacts of climate change in the polar regions. There was also

a well-attended poetry workshop with Caribbean poet and dramatist Kendel Hippolyte that was recorded and archived.

Jerry reported that the association is still in reasonably good financial health with enough in the bank to be able to manage for a year if need be. This past pandemic year proved that a wise strategy. He encouraged the cultivation of a new culture of membership beyond the annual conference as our numbers are only around 40. In responding to questions from the audience, he noted that that number included a half-dozen lifetime members and that this year was an anomaly as we had waived graduate student fees on account of the pandemic.

### Mark Terry, Media and Communications Officer:

Mark reported that membership on the CCLA Facebook page increased from 386 in 2020 to 950 in 2021.

#### Important journal updates:

- The journal has put shipping on hold since the beginning of the pandemic (March 2020);
   volume 47 has been printed but is being stored at the printer's facility. It is expected that shipping will resume in the summer.
- The pandemic has affected the journal's book review section, although we have been able to make a gradual transition to digital review copies with select publishers and reviewers.
- Application deadline for the next SSHRC/CRSH triennial competition cycle (Aid to Scholarly Journals) is expected to be in September 2021, although the agency website has no updates.

#### **OTHER BUSINESS:**

The question of amending the Constitution was raised. Susan Ingram noted that Article VI governs amendments:

- 1. Amendments to the Constitution and By-Laws of the Association are made only under the following conditions: at a regular meeting, by a two-thirds majority vote of the members present; OR by a two-thirds majority vote by all responding members of the Association by electronic ballot.
- 2. Any proposed amendment must be presented in writing to the membership at least one month before the regular meeting that will vote upon it; OR one month prior to the opening of internet polling.
- 3. The Constitution and By-Laws should be reviewed no less frequently than every ten (10) years.
