

Hello everyone and welcome to this morning's session, Working With KF Modified: Changes and Enhancements.

We'll begin by reviewing the origin and philosophy behind KF Modified along with some of the special features at work in the classification scheme: for example, geographic divisions, subject cutters, and the treatment of constitutional law.

Then we'll take a look at some of the recent enhancements introduced including the expansion of the section on Quebec civil law and the enhancements to immigration and emigration, and nationality and citizenship found in the special topics for constitutional law.

We'll end with some cataloguing exercises that will give us all a chance to apply KF Modified and see how these enhancements will work with some real life examples.

The Origin of KF Modified

- as legal publishing grew law libraries needed to better manage their larger collections
- in 1968 the Library of Congress released a draft of classification, KF for federal U.S. law
- no immediate plans to develop a classification scheme for Canadian law
- a group of law librarians decided to adapt the draft U.S. and use the modified version in Canadian law libraries

You've heard this story many times before I'm sure. In the late 1960s as the legal publishing industry began to flourish, Canadian law libraries found their collections were becoming to large to be effectively managed with a simple author/title and broad subject heading arrangement.

The trouble was there was no classification scheme for Canadian law. The only legal classification schedule available was a draft from the Library of Congress for the federal law of the United States.

There were no immediate plans for a Canadian classification scheme for law so a group of Canadian law librarians, led by Shih-Sheng Hu, from the University of Manitoba Law Library, decided to adapt the draft U.S. schedule and modify it for use in their Canadian law libraries.

The Philosophy of KF Modified

- in their collections Canadian law librarians had recognized the natural similarities in the law and found a subject approach facilitated browsing and access to legal resources
- areas of the collection with larger publication outputs were grouped by topic and further subdivided by jurisdiction
- the "geographic division" was the mechanism used to enable this subdivision in the classification scheme

The Canadian law librarians at the time recognized that they had been grouping the literature based on the natural similarities found in the law. They also realized that this arrangement was ideal for collection browsing because it kept similar resources grouped together by subjects.

In areas where publishing was greatest, for example, criminal law, criminal and civil procedure, etc., a geographic division was used to further group resources according to the jurisdiction that the law applied to.

We'll look at the geographic division, also known as the "G.D.", later in the session.

Development of Legal Classification

- the Library of Congress continued developing classification schemes for law
- LC developed individual schemes for each legal system/jurisdiction, for example:
 - · class KF for American law was released in 1969
 - · class KD for British and Irish law was released in 1973
 - · class KE for Canadian law was released in 1976
- there are currently X classification classes available for law

The Library of Congress continued to develop classification schemes for each legal system releasing the completed American schedule in 1969. The scheme for British and Irish law came out in 1973 and the classification scheme for Canadian law was released in 1976.


KF Modified had been in use in a large number of Canadian law libraries for six or seven years by then. Dividing collections by subject first continues to be a popular choice for many common law libraries in Canada.

Let's take a look at the difference between these two organizational philosophies.



If we consider each of the arrows in this diagram a topic in a particular jurisdiction, say for example criminal law, you can see how the topics are scattered throughout the collection.

Each of the jurisdictions will have a particular number assigned for criminal law.



In this diagram those same books would be brought together in a single location when the first order of division is by subject first. As mentioned earlier further subdivision by jurisdiction are possible in the KF Modified system using the geographic subdivision.

Now this is not to say that one organizational method is superior to another, just that there are many ways a collection can be organized and some methods can be preferred over others in some situations.

The Geographic Division (G.D.)

The geographic division, or G.D., is a special code that represents a common law jurisdiction. The G.D. is placed immediately after the class number grouping similar resources together by jurisdiction.

In this example, KF 1536 is subdivided by the G.D. for Canada: ZA2.

The Geographic Division (G.D.)

Note that because KF Modified was based on the American schedule for KF, a G.D. for the United States was never created.

The Geographic Division (G.D.)


Here's the G.D. instruction to the cataloguer as it appears in the KF Modified schedule:

Civil procedure 8840 General works. (**G.D. 8840 [8840-8855]**)

Here is the instruction to use the geographic division as it appears in the KF Modified schedule. This is the G.D. instruction for KF8840, the number for civil procedure.

This instruction says that for any number that falls within the classification range of KF8840 to KF8855, the cataloguer should use KF8840 followed by the relevant G.D.



Here for example is a work on civil procedure in Ontario which would go in KF8840 with the G.D. for Ontario: ZB3.

Here's another example for a work on labour law in Australia. The number for labour law is KF3320 and this is followed by the G.D. for Australia: ZD4.

The Subject Cutter

- Subject cutters are a feature found in the Library of Congress Classification
- Subject cutters are used to subdivide a general subject into a more specific subject
- Subject subdivisions are usually assigned their own classification number
- Subject cutters are used in certain situations

The subject cutter is a feature of the Library of Congress Classification scheme in general and is not peculiar to KF Modified. An understanding of why and how they are used is however necessary especially in the area of constitutional law.

Subject cutters are used to subdivide a general topic into a more specific one. In many cases the more specific topic will be assigned its own class number. But you'll find subject cutters used in certain situations throughout the Library of Congress Classification.

The Subject Cutter

Examples

Works on diverse legal aspects of a subject falling within several branches of the law:

Here are some examples found in at KF390.5 the number for 'Works on diverse legal aspects of a subject falling within several branches of the law.'

Like the geographic division, the subject cutter immediately follows the class number.

We'll see how this is used in the area of constitutional law which we'll look at now.

- This subject area required extensive modification during the development of KF Modified
- KF Modified provides a special range of numbers for the constitutional law of non-U.S. common law countries

* Note: U.S. constitutional law is found at KF 4501-5130

The area of constitutional law was a subject area that required it's own development to distinguish it from U.S. constitutional law already present in Library of Congress class KF.

A special range of numbers was created to organize the constitutional law of non-U.S. common law countries.

There are three main numbers for Canadian constitutional law:

KF 4481 Documents, sources, etc.

KF 4482 General works about the Constitution

KF 4483 Special topics & specific subject areas

There are three main numbers available for Canadian constitutional law. In this session we'll be focusing on the last one, KF4483, which is used for special topics and subject areas under constitutional law.


Great Britain & Ireland, Australia and New Zealand each have a similar set of numbers that divide just like the numbers outlined for the constitutional law in Canada.

Other common law jurisdictions, with generally smaller publication output, are assigned a single number with a number that represents their particular country. So, for example, KF4496 J3 is used for Jamaica.

As you can see here there are a number of special topics found under KF4483. This is a selected subset of the topics that are available.



So for example this book on Canadian human rights law would be assigned KF 4483 C5 which is the special topic area for civil and political rights.

KF 4483 C5 has been expanded to bring out particular aspects of the topic:

KF4483 C5 is a number that had previously been expanded to bring out specific aspects of the topic 'civil and political rights.'

Here's an example for a publication that annotates the Canadian Charter of Rights and Freedoms, which would fall at KF 4483 C5 the area for civil and political rights, and more specifically C518 for annotated works on the Charter.

As we'll see shortly this is the same kind of expansion that has been added to enhance the areas of Immigration and Emigration, and Nationality and Citizenship.
